ORDER

WHEREAS, the Chalmendra Anand Rado Institute of Medical Sciences, Karimnagar affiliated to the Kaloji Narayana Rao University of Health Sciences, Warangal vide its letter No. CAIMS/01/MCI/PG/NMC/2022/53 dated 12.5.2022 had applied for renewal of recognition of twelve (12) seats of MD (General Medicine) qualification in respect of students being trained at the Medical College, having an annual intake capacity of eighteen seats in the said course.

2. WHEREAS, the Post Graduate Medical Education Board (PGMEB) scrutinized the Standard Assessment Form, of the inspection conducted of the College on 6.6.2023 and found the following deficiencies:-

- (i) Non-marking of attendance by the faculty on the Aadhaar Enabled Biometric Attendance System (AEBAS);
- (ii) The report of the Aadhaar Enabled Biometric Attendance System showed deficiency of five Associate Professors, eleven Assistant professors and four Senior Residents; and
- (iii) Most of the patients were admitted two-three days before the inspection/ assessment.

3. WHEREAS, the College was intimated of the above deficiencies vide PGMEB's letter No. 35/751(24)/2022-PGMEB/046973 dated 09.08.2023 and the medical college was given an opportunity to submit a written explanation in respect of the deficiencies. The College furnished its reply to PGMEB vide letter No. CAIMS/01/NMC/PG/2023/189 dated 29.8.2023. The reply of the College was examined by the PGMEB and found that it had failed to comply with the requirements prescribed in the various regulations notified by NMC/ erstwhile MCI and has compromised with the quality of medical education. Hence, considering the deficiency of faculty in the Department of General Medicine of the medical college, PGMEB vide Order No. 35/751(24)/2022-PGMEB/060580 dated 18.12.2023 decided to recognize fourteen seats of MD (General Medicine) and to reduce the annual intake capacity in the course of MD (General Medicine) from the existing eighteen to fourteen seats from the Academic Year 2024-25.

4. WHEREAS, the College had preferred First Appeal before the National Medical Commission under Section 35(5) of the NMC Act, 2019 and Section 9 of Maintenance of Standards of Medical Education Regulations, 2023 (MSMER-2023).

5. WHEREAS, the Appeal Committee of the NMC in its meeting held on 2nd and 3rd April, 2024, upheld the decision taken by the PGMEB.

6. WHEREAS, the College had preferred Second Appeal before the Ministry of Health & Family Welfare under Section 35(7) of NMC Act, 2019 against the decision taken by PGMEB/NMC. The Second Appeals Committee of Ministry of Health and Family Welfare has remanded back the proposal of the College to PGMEB/ NMC for renewal of recognition of the recognized 12 seats and has also directed NMC to allow admission for six additional seats, which were already allowed on the basis of LoP for 2024-25.

7. THEREFORE, PGMEB accords the approval in terms of Section 25(1) and 35(4) of NMC Act, 2019 and regulation 7(1) of MSMER-2023 for **continuance of eighteen seats** of the course of MD (General Medicine) in respect of students being trained at the Chalmeda Anand Rao Institute of Medical Sciences, Karimnagar under the Kaloji Narayan Rao University of Health Sciences, Warangal, Telengana.
